
# Doyle Mills of Brownwood, Texas and the Battle of Osan in the Korean War

# The Korean War 6/25/1950 to 7/27/1953





#### Task Force Smith



- LTC Charles B. Smith.
- 1939 West Point grad.
- At Pearl Harbor at Schofield Barracks.
- Commander of 1st Bn./21st Inf. Regt. of the 24th Inf. Div.
- Based on Kyushu Island, Japan.

### C-47 at Itazuke Air Base, Japan



- Only Co. B and C of 1st Bn/21st Inf Regt.
- Half of Bn's HHQ Co.
- Half of communication Plt. of the Bn.
- Only two 4.2. in mortars and two 75 mm recoilless rifles.
- Battery A of the 52nd FA Bn of the 24th Inf Div.
- Some officers and men of Co. M volunteered.
- Total of 540 men.
- Left Japan on 6/30/1950.




### Task Force Smith marching from Osan



### Osan, South Korea

- Village of Osan 20 miles south of Seoul, the capital.
- Early morning hours of 7/5/1950 Task Force
   Smith dug in alongside the Osan-Suwon road north of Osan.








#### Battle of Osan

- Rainy, overcast morning.
- KPA tanks engaged the task force and fought their way through the meager defenses.
- KPA's 16th and 18th Inf. Regt's had a combined strength of almost 5,000 troops.
- Temporarily halted, then outflanked Task Force Smith over running the hillsides overlooking the road.



#### **US** Casualties

- Initially thought 150 to 180 killed in action, wounded in action or taken prisoners of war.
- Few of the POW's survived the war.



### PFC Doyle Mills



- Born 1/17/1933 in Santa Ana.
   Twin brother of Hoyt Mills.
- Son of Augustus G. Mills and Bessie Mamie Cothern.
- Family moved to Brownwood in 1943/1944. Lived near the brickworks factory.
- Step father Paul Elmer Burson signed paperwork allowing them to join the Army in Jan 1950.
- Sent to Japan as HWI (heavy weapons infantryman).
- KIA on a hill overlooking the road.

### Doyle Mills

- First man from Brownwood to die in the war.
- First man from Brown County to die in the war.
- One of six Texans to be killed in action at the Battle of Osan.
- Bodies recovered after the Inchon landing in September 1950.



#### Two Texans died before Battle of Osan

- USAF Capt. Remer L. Harding of Ft. Worth.
- WWII B-25 bomber pilot. 66 missions.
- TCU graduate.
- 13th Bomb Sq./3rd Bomb Wing in Japan.
- Crashed and died at Ashiya AB, Japan after bombing mission in Korea on 6/28/1950.
- Ft. Worth National Cemetery in Dallas.



### USAF Tech Sgt Jack A. Morrison

- HOR: Grayson Co., Texas.
- Declared MIA on 6/30/1950 over Korea.
- Operation Raven. Wife Norma and two children airlifted back to USA.
- Morrison's body later recovered.


# Four Texans Taken Captive at Battle of Osan




- Cpl. Omer L. Anderson.

- Died as POW on 12/20/1950 in North Korea.

- Surgical technician in medical platoon.
- Survived the Tiger Death March.
- Died from malnutrition on 5/31/1951 at An-Dong, North Korea.

### Master Sergeant Harvey T. Vann

- Died as POW on 1/31/1951 in North Korea.



### PFC Anselmo F. Zamora

### USAF 1Lt. James E. Cantwell

- Born in Comanche.
- 1946 draft registration living at 1018 Santa Clara, Brownwood.
- 21st FTR Bomber Wing in Victorville, CA.
- Pilot of F-86 jet. Crashed northwest of Ft. Worth on 8/7/1953.
- Buried Greenleaf Cemetery, Brownwood.



#### PFC Roland W. Cullins

- 3rd Bn./35th Inf Regt. of the 25th Inf Div.
- KIA on 2/14/1951 in South Korea.
- Bangs Cemetery.

# Navy Chief Aviation Electronics Mate James N. Henson

- Brownwood H. S.
- Enlisted in 1940.
- Career navy man.
- WWII: Flight crew on USS Wasp when it sank 9/15/1942. Escorting transports with Marines to Guadalcanal. His plane went down at same time.
- Distinguished Flying Cross.
- Assigned to aircraft carrier in 1953.
- Died in plane crash on east coast in Jan. 1953.
- Father Boyd James lived at 1802 Fisk, Brownwood.

# Army Sgt. First Class Willie E. Lee

- Career soldier. Had re-enlisted in 1945 at Camp Bowie.
- KIA on 7/28/1950.
- HOR: Waco.

# Army Private Jasper V. Marquez

- Enlisted from Brown County.
- 2nd Inf Div.
- Seriously WIA on 9/6/1950 in South Korea.
- Captured as POW during Battle of the Chosin Reservoir on 11/28/1950.
- Died as POW on 1/20/1951 in North Korea.

- HOR: New Mexico.
- 223rd Inf Regt of the 40th Inf Div. (CA Natl Guard).
- KIA on 6/19/1952 in North Korean sector.



#### KPA advanced southwards

- 7/6/1950 fighting at village of Pyongtack.
- Night of 7/7 to 7/8/1950 fighting at village of Chonan.
- 7/10 to 7/12/1950 Battles of Chonui and Chochiwon.
- 7/14 to 7/21/1950 Battle of Taejon.
- By the end of the month the 24th Inf Div had 3,602 KIA and WIA, and 2,962 POW out of original strength of 15,965.

- 82 POW (32 died in captivity).



#### Task Force Smith - Tiger Survivor POWs



July 5 - 8, 1950 The first American POWs captured in the Korean War are forced to march through the streets of Seoul Korea under Red banner which proclaimed "the Red cause as righteous and attacked the U.S. intervention."



## POW'S captured in July 1950

- Inchon landing on the west coast of South Korea.
- In September 1950 taken by rail to Pyongyang and then to Manpo further north into North Korea.

#### Tiger Death March

On 10/31/1950 764 POW'S and 81 civilians met KPA Major Chong Myong Sil "The Tiger."

- From 11/1 to 11/9/1950 the Death March.
- Marched from Manpo to Chunggang-jin near the Yalu River near China.
- The Tiger was sadistic. Enjoying killing and the suffering of the POW's.
- No mercy. Three women (two nuns) shot.
- In charge of the prisoners well into the spring of 1951.



- Field communications chief in Co. L of the 3rd/34th Inf Regt.
- POW at Battle of Taejon on 7/15/1950.

### Made an example to the stragglers.

- 11/1/1950 personally executed by "The Tiger."
- Refused a blindfold as he was facing the assembled POW's.
- Stood proud and tall.
- An example for the soldiers and civilians.



### Forest Pine Cemetery in Greenville




#### Nine days of marching 120 miles

- Total of 89 people shot by "The Tiger" on the march, POW's and civilians.
- Year later fewer 300 alive.
- By the end of the war 66% of the original survivors of the Death March had died.
- Only after the Chinese took over the control of the POW's did their living conditions improve.
- Only 278 POW's of the march made it home to the USA.

# Johnson's List's: PFC Wayne A. "Johnnie" Johnson

- Born in Ohio.
- Co L of the 21st Inf Regt.
- POW on 7/11/1950.
- Personally recorded the names of all those who died at great risk.
- Caught once with a list. Punished.
- Had a back up list.
- Tiger Survivor List smuggled out in toothpaste tube in 1953. Had more than 400 names.



#### "Johnnie" Johnson

- POW reunion in 1995.
- Army Sgt. Victoria Bingham of the DOD's POW/MIA office.
- "Johnson List."
- Johnson awarded Silver Star Medal for his efforts in making and hiding the list of POW's who died.
- Died 6/1/2011 in San Marcos, Texas.
